Project Description

Metis Settlements General Council is seeking a “Contractor” with expertise to facilitate a Community safety needs/ barrier/gap analysis Settlement by Settlement and develop a strategic plan which presents options and recommendations for solutions, long-term investments and approaches for Mental Health and Addiction and Community Safety.

Background

In 2015-2017, the Metis Settlement Health Board completed a Phase I and Phase II Community Health Assessment. The assessment concluded that across all the 8 Settlements alcohol and drug addictions were mentioned in every data source as the most critical issue facing the Metis Settlements. To fully understand the magnitude of addiction and mental health further analysis needs to be undertaken with the communities, to establish priorities and facilitate a collaborative action plan.

Deliverables

Working in conjunction with the Metis Settlements Health Board:

1. Develop/implement a community assessment – qualitative/quantitative and applicable to various age groups for each Settlement
2. Complete a gap analysis of current information as per the community assessments/ programs and services (internal/external) available to members and barriers to accessing services.
3. Develop a community inventory list of services and programs as identified.
4. Data Analysis using both inductive and deductive approaches.
5. Utilize qualitative and quantitative methods to complete analysis.
6. Produce a final Strategic Plan that presents options and recommendations for solutions and long-term investments.

7. Provide monthly updates on status of work completed to the Metis Settlements Health Board Coordinator.

The project will commence upon retention of the contractor, some components require work to be completed by October 30, 2024 (presenting a preliminary report to the Health Board) with final report being completed before March 31, 2025.
